OTAC Q1 Notes

Jay:

- We're in an era of abundance
- Inflation Reduction Act is the biggest investment in conservation at the center of everyone's mind
- National Leadership Meeting is next week, IRA will be the focus

Gail:

- Accessing ways to work with new customers
- CRP software has been turned off in last couple weeks, planned to be turned on in a week or so
- IRA working on assistance for distressed farmers and increased outreach

Sarah:

- ELAP and Livestock indemnity program have issued a waiver. Have it in by Jan payment period deadline to be considered eligible
- Emergency relief program started
- CRP we don't have authority to enter into new CRP contracts as the Farm Bill has expired
 - Which is why the CRP tool is locked currently
 - Hoping to have access next week
- Working with partners on annual CREP report

Tom:

- IRA FY23 and FY24 update
- Reminders about IRA funds, funds ramp up to FY26 and then decrease

- Reviewed Climate Smart Ag and Forestry (IRA specific) practices and enhancements available
 - <u>https://www.nrcs.usda.gov/conservation-basics/natural-resource-</u> <u>concerns/climate/climate-smart-mitigation-activities</u>
- FY24 NRCS OR updated their top 10 priority practices based on input from OTAC
 - 90% cost share rate
- Highlighted FY24 Watershed Priority Practices where some practices have a higher cost share rate
- Agricultural Conservation Easement Program updates
 - Regional Conservation Partnership Program updates
 - 22 projects currently, about \$100M of NRCS funds, \$100M in partner funds

Crystal:

- Integrated Water Resource Strategy intro, project teams, update timeline
- Update to requirement to produce biennial progress reports
- IWRS updates are now required no more than every 8 years (previously 5 years)
