The United States Department of Agriculture Natural Resources Conservation Service and the American Bird Conservancy Improving Forest Health for Wildlife Resources in Minnesota, Wisconsin, and Michigan (IFHWR) Regional Conservation Partnership Program (RCPP) Land Management (LM) Signup.

Background

Improving Forest health for Wildlife Resources will promote voluntary, incentive-based conservation on private and Tribal lands. ABC's RCPP project supports the creation of high-quality GWWA breeding habitat using science-based best management practices (BMPs), and, as part of a comprehensive regional initiative, has delayed consideration for federal listing. The goal is to maintain progress to sustain a diverse and healthy mosaic of forest types and age classes across the landscape. This project also expands to include young jack pine management to increase Kirtland's Warbler (KIWA) habitat. KIWA is a conservation-reliant Species of Greatest Concern recently federally listed as endangered with focus in WI and MI through this project. **KIWA will not be part of the MN project in FY 2024.**

RCPP offers financial assistance to agricultural producers to implement on-farm Land Management (LM) activities. Eligible land is determined by the Natural Resources Conservation Service (NRCS) and is based on an identified resource concern. Eligible producers may apply for financial assistance on conservation practices that will address the identified resource concerns in the project area.

Application Period

Applications may be taken at any time. Producers must submit an RCPP application on or before **December 15, 2023** to be considered for funding.

Eligible Project Area

Producers located within the Improving Forest Health for At Risk Wildlife Resources project area are eligible to participate in the project's RCPP sign-up. The conservation practice(s) identified in the application must be located within the project area to be eligible for financial assistance consideration through the RCPP sign-up.

MN Counties included in the project area include (map below): Beltrami, Itasca, St. Louis, Cass, Becker, Hubbard, Crow Wing, Carlton, Pine, Mille Lacs, Lake of the Woods, Clearwater, Wadena, Roseau, Lake, Kanabec, Morrison, Koochiching, Aitkin, Mahnomen

Funding

Available RCPP-LM #2245 IFHWR funds will be allocated based on the numerical ranking system set forth on the web site. All ranking will be conducted in CART. If insufficient funds are available to fund all eligible applicants, applications will be held and may be funded with extra RCPP-LM #2245 IFHWR funds if available or deferred to the next ranking period.

Payment Limitations

Each RCPP- LM contract with a person or legal entity is limited to \$450,000 over the term of the contract, and each RCPP-LM contract with a joint operation (Farm Service Agency business type 2 or 3) or group projects may have a contract limit of up to \$900,000.



- b. No payment caps on any of the eligible activities.

NRCS and Partner Roles

The American Bird Conservancy negotiated the project to perform most of the Technical Assistance work. NRCS will reserve the duties that are inherently governmental. NRCS in general will conduct and process eligibility determinations, complete the final steps of NEPA, process contract obligations and modifications, make payments, and conduct status reviews. In some cases, both NRCS and ABC may perform a role, such as continuously accepting project applications. Most of the time ABC will accept and load applications into Conservation Desktop (CD). The rest of the work associated with applications, planning, contract development, practice installation and checkout should be conducted by ABC staff. Communication between field offices and ABC is critical to meeting deadlines and managing applications, contracts, and payments.

NRCS Roles:

- NRCS Field Office (FO) will conduct producer eligibility determinations by pulling the FSA Subsidiary Business File, and communicating eligibility needs with the applicants,
- NRCS FO may accept applications and load them into CD, however NRCS must communicate those applications to ABC field staff,
 - Note: If an office accepts an application, send the application to ABC staff
 with a Farm and Tract number. If such information is not available, send the
 applicant to FSA to set up FTE and all other USDA eligibility so the case file
 can be created. Communication will also avoid duplicate entries of
 applications into CD.
- NRCS FO will ensure NEPA is completed accurately, including that T&E, Cultural Resources, and CART information is entered, and sign the NEPA as the RFO,
- NRCS State Office (SO) will work with ABC staff to determine how far down the ranking list to preapprove applications,
- NRCS FO will send Preapproval Letters and begin working on the 1155, 1202, and verify we have recent and accurate 1199a and Vendor Codes,
- NRCS FO will acquire the participant obligation signatures (including signatures on Conservation Plan and Map, Implementation Requirements, and contract), perform obligations, and put together the bulk upload packages for CD-Document Management System,
- NRCS will process contract modifications, which may be initially communicated to the field office from ABC staff,
- NRCS will accept ABC red-lined Implementation Requirements, photos, and maps, and ABC staff documentation that the practices are installed to meet NRCS standards and specifications,
- NRCS will complete the 1245 Payment Application and all payment processes,
- NRCS FO will complete contract Status Reviews,
- NRCS will work to fund projects through EQIP that are similar to or in support of ABC projects when they cannot be obligated through RCPP,

ABC Roles:

- ABC will conduct producer outreach to promote the project and solicit applications,
- ABC may accept applications and load them into CD, and communicate the applications to NRCS for eligibility determinations,
- ABC will complete the Conservation Planning Process, including implementation requirement designs, conservation plan, conservation plan maps, HSI, Conservation Assessment Ranking Tool (CART) assessment,
- ABC will answer the CART Ranking questions, complete the estimated cost worksheet, enter the estimated costs, and submit the ranking into CART,
- ABC will complete all NEPA parts through section R on the CPA-52 form, including entering the CART information,
- ABC will have project implementation oversight, including red lining the Implementation Requirements and Map, and providing the information/documentation to NRCS,
- ABC will make the field office aware if a contract modification is needed prior to practice implementation,
- ABC may work on old RCPP projects and EQIP projects they may have started before the new RCPP project #2245
- ABC will provide their own transportation to project sites and will not use NRCS vehicles
