Definitions

Urban Agriculture – USDA:

• "Urban agriculture includes cultivating, processing and distributing agricultural products in urban and suburban areas."

Small Farms – USDA:

- Gross cash farm income under \$250,000.
- 91% of farms are small
- Large farms (\$250,000 +) account for 85% of the market

FA Prioritization Approach

- Urban Boundary
 - 2 mile buffer
 - 51% PLU intercept
- Fund Pools
 - Urban: Just less than 5% budget
 - HU Pools: 5% of budget






CSP Updates
